## CITIZENSHIP AND VISA APPLICATIONS

### Applying for Permanent Residence (Green Card)

The United States government offers many avenues for foreign nationals to obtain permanent residency or a green card. Green cards are commonly obtained through a family member, through a job, or due to refugee or asylee status. Other considerations can be made in special circumstances.

### Applying for a Visa

There are many types of visas that give individuals authorization to live, travel or work in the United States. Visas are typically temporary permits to work, study, travel (for business or pleasure), or participate in a cultural exchange program.

### Applying for Citizenship

Applying for U.S. citizenship can be a long and difficult process. The Law Office of Anthony J. Mamo can help you through the naturalization process. The firm will analyze clients' situations and provide advice on the application process, help prepare and file the appropriate forms and paperwork, and help clients understand the interview process and questions. Common naturalization processes include naturalization as a U.S. citizen through parents, naturalization through marriage, transition from permanent resident to naturalized citizen and more.

## DEPORTATION DEFENSE

### Provisional Waiver of Unlawful Presence

Spouses of U.S. citizens who are not legally in the country may apply for temporary permission to stay in the United States before they depart for an immigrant visa interviews at a U.S. embassy or consulate. The Law Office of Anthony J. Mamo will take the steps necessary to help terminate or dismiss your removal proceedings.

### Deferred Action for Childhood Arrivals

Individuals who were unlawfully brought to the United States as children may apply for deferred action to avoid deportation or removal. The firm will help you navigate the criteria needed to apply for deferred action and will help you file the appropriate paperwork with the U.S. government.

### Relief from Removal (Deportation)
