APPLICATIONS FOR IMMIGRANT VISAS

Family-Based Sponsorship (including Marriage Petitions)

If an immigrant has a family member with U.S. citizenship, he or she may be eligible for family-based sponsorship. The resident relative should contact an attorney for assistance in completing the immigrant visa petition before the immigrant applies for an immigration benefit. How long the process will take varies considerably based on whom the immigrant's petitioner is. A petition filed by a spouse may lead to a green card in less than a year, while the same petition filed by a brother or sister may take over a decade to result in a visa.

Employment-Based Sponsorship

If an immigrant is presented with a permanent employment opportunity or is currently working on a nonimmigrant visa, he or she may be eligible for employment-based sponsorship. The employer will need to fill out a lot of paperwork during the multi-step process, and it is in the immigrant's best interest to make the process go as easily as possible. He or she should contact an immigration attorney for assistance.

Adjustment of Status Proceedings and Consular Proceedings

If an immigrant is already in the U.S. on a nonimmigrant visa, he or she may apply for an adjustment of status to become a lawful permanent resident. If the immigrant has not yet entered the U.S., he or she may apply for a visa from outside of the U.S. Once the visa is approved, an interview will be conducted at a U.S. consulate in the country of birth or the country of residence.

Removal Hearings

If an undocumented immigrant is facing a removal hearing (formerly deportation proceedings), he or she should seek the guidance of an immigration attorney immediately. There may be measures that can be taken to allow them to stay in the United States.

FAMILY LAW

Custody, Child Support, Visitations and Guardianships of Minors

Joint custody is preferred and implies that both parents will share in making major decisions concerning the child's upbringing. Sole custody occurs when one parent is not involved, i.e., prison, or suffers from mental incapacity. Visitation is the right of the parent who does not have residential custody to spend time with the child.

In determining the amount to be paid for child support, the court will apply the Child Support Standards Act that designates a percentage to be used to determine child support based upon the number of children in question. Prenuptial Agreements

Prior to marriage, many couples choose to arrange prenuptial agreements. These agreements outline how wealth would be distributed in the event of a divorce. A "prenup" helps spouses avoid the expense and turmoil of litigating future financial issues by agreeing to certain terms without the hostility that often accompanies divorce proceedings.

Separation and Divorce

A divorce is a legal decree signed by a judge officially dissolving a marriage. Sometimes a divorce is contested, meaning that one partner does not want to get divorced and will argue against it, and sometimes it is not. Regardless, the process of obtaining a divorce the family can live with is often a very complicated one. If you are considering a divorce, the attorneys at The Law Office of Dorothy M. The executor, if acting pursuant to a Last Will and Testament, or administrator for a person who dies without a Will, must be authorized by a Surrogate's Court with authority to gather and administer the estate, satisfy any outstanding debts, taxes due, and other obligations, and then pass the remainder to the beneficiaries according to the decedent's wishes and New York law.
