New & Noteworthy Personal Injury Results ————

- **\$5.5 Million** result for pain and suffering. Facts: A young patient in a health care facility required multiple surgeries and the insertion of a feeding tube in his abdomen. We established that the need for the surgeries and feeding tube was the fault of the health care facility's negligent care of this patient.
- **\$3.2 Million** result after trial verdict and all appeals for pain and suffering, lost wages, and medical care. Facts: A police officer driving his SUV patrol car on a beach ran over a middle-aged sunbather causing multiple crush injuries requiring multiple neck surgeries and an inability to work at his usual employment. We established that the incident was entirely the fault of the police officer.
- **\$2.8 Million** result at trial for pain and suffering. Facts: A factory worker suffered disfiguring injuries to his dominate right hand while cleaning a machine at work. We established that the machine was defectively manufactured.
